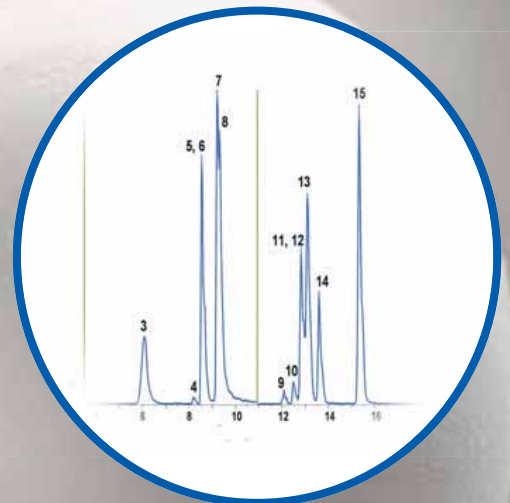

When handling CMR drugs (e.g. cytostatics), unintentional cross-contamination from contaminated gloves, vials, protective clothing, shoes, or wheels from transport trolleys, etc. can easily occur. Accidents or disruptions in airflow of safety cabinets can also lead to the release of cytostatic drugs. In the German MEWIP study (Monitoring-Effect-Study for Wipe Sampling in Pharmacies) cytostatic drugs were found in 61% off all wipe samples.

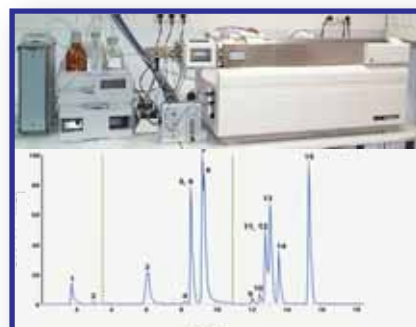
Wipe sample kit "PharmaMonitor":
